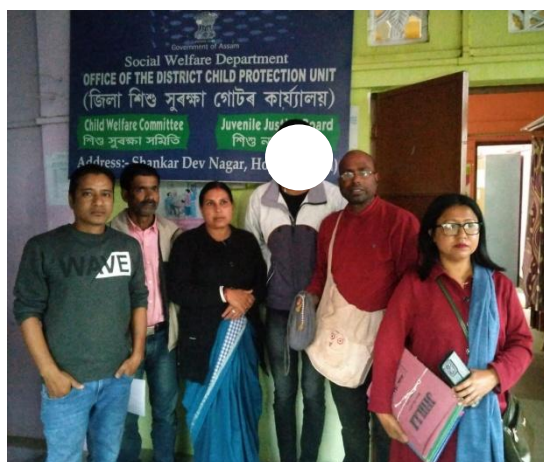
Participated in Training program for **Child Welfare Police Officer** at SDO (Civil) Conference Hall, Hojai on 20<sup>th</sup> January, 2023.
